- We use cookies strictly for **session management**. We do not use cookies for analytics, advertising, or tracking.

2. How We Use Your Information

We process your personal data only where lawful under UK GDPR, including when:

- It is necessary for the performance of a contract (e.g., creating and managing your account).
- You have given **consent** (e.g., subscribing to our newsletter).
- We have a **legal obligation** to comply with.

We use your data to:

- Create and manage your account.
- Enable you to sign in, update details, and use our services.
- Send newsletters (if you opted in).
- Respond to your enquiries.
- Comply with legal obligations.

We **do not sell, rent, or share your personal information with third parties**, unless required by law enforcement or regulatory authorities.

3. Account Deletion

- You may delete your account at any time.
 - Upon deletion, your account will first be marked as deleted in our database.
 - After **24 hours**, your account and associated personal information will be permanently erased.

4. Data Retention

- We retain your data only for as long as necessary to fulfil the purposes outlined in this policy or to meet legal requirements.
 - Newsletter subscriptions are retained until you unsubscribe.

5. Security

We take appropriate technical and organisational measures to protect your data against unauthorised access, alteration, disclosure, or destruction.

6. Your Data Protection Rights

Under UK GDPR, you have the following rights:

- **Right of access** – Request a copy of the personal data we hold about you.
- **Right to rectification** – Request correction of inaccurate or incomplete data.
- **Right to erasure** – Request deletion of your data (“right to be forgotten”).
- **Right to restrict processing** – Request limits on how your data is used.
- **Right to data portability** – Request your data in a portable format.
- **Right to object** – Object to certain types of data processing.
- **Right to withdraw consent** – Withdraw consent (e.g., newsletter subscription) at any time.
